### **Community Music Jukebox Release Agreement:**

- I. Artist hereby warrants that it is the legal copyright owner of both the sound recording copyright and the copyright in the song. Thereby, Artist warrants it has the full legal authority to grant WCRS a non-exclusive license to promote the work of Artist through any or all of the following, but not limited to the following, methods:
  - a. WCRS 102.1 and 98.3 FM
  - b. The Community Music Jukebox
  - c. The WCRS Website / Podcasts / and any other medium now known or hereafter devised.
- II. Artist agrees to indemnify WCRS, its successors in interest, assigns, licensees, affiliates, officers, employees and agents from all claims, actions, damages, liabilities, losses, costs and/or expenses, including reasonable attorneys' resulting from any breach or claim of breach by Artist of any representations, warranties and agreements made herein by Artist.
- III. Artist understands and agrees that WCRS is an independent community radio station and that submitting music in no way obligates WCRS to select any of the music for airplay and promotion on WCRS 102.1, 98.3 FM or the Community Music Jukebox.
- IV. Artist understands and agrees that WCRS does not and will not pay any royalties for airplay or promotion for any use, including but not limited to, using the music on internet radio stations, terrestrial radio stations, website, or on the Community Music Jukebox.
- V. WCRS agrees that Artist may revoke this Agreement at any time.
  - a. Artist agrees that it is Artist's legal obligation to notify WCRS in writing if Artist wishes to revoke permission and no longer wishes to have Artist's music promoted by WCRS.
  - b. Artist agrees that WCRS will have 30 days from date of receipt of written notice to remove the music from any use including, but not limited to, WCRS 102.1, 98.3 FM, the WCRS Website, WCRS Podcasts, and the Community Music Jukebox.
